Eligibility: Military families of active duty Service Members **E5 and below (NO EXCEPTIONS)**, regardless of branch, may submit an application for the Fort Gordon Christmas House. National Guard and Reserve Component Service Members must be currently serving on active orders and have been on those orders for a minimum of 30 days at the time of submission.

****Application submission dates: 15 September thru 29 October 2020****

1. Only one application per household/family will be accepted for children aged six (6) months through thirteen (13) years.
2. All applications will be considered, however, not all applications will be approved.
3. Applications are available online www.fortgordonchristmashouse.com

Please print: incomplete, illegible applications will not be processed.

4. Families selected will be notified by their unit representative.
5. Distribution will take place on **8, 9, 10, & 11 December 2020, at building # 39109, 40th St. (behind the Main Exchange)** on Fort Gordon. The date and time for each unit will be determined by lottery. If neither the Service Member or family member is available on the unit distribution day, the unit commander/representative will be responsible for selecting gifts and signing the receipt.
6. Emergencies and special circumstances will be handled on a case-by-case basis.
